BOOKING TERMS & CONDITIONS

1. Contract - Your contract is with YUNDA Yachting. When you sign the booking form and make the deposit payment you are accepting these conditions. The booking agreement becomes binding when signed by you and confirmed in writing by YUNDA Yachting. This contract will be construed in accordance with English Law and it is agreed that all parties will submit to the jurisdiction of the Courts in the state of New South Wales.

2. Booking procedure - Bookings must be made in writing on our booking form and accompanied by a deposit of 25%. We will accept provisional bookings by telephone or email and will normally hold them for 3 days (but less if made within 2 weeks of the charter start date), after which they will expire unless the signed booking form is received and confirmed by our office.

3. Payment - The booking deposit must be sent with your booking form to secure your booking. The balance payment is payable no later than 3 weeks prior to the start date. If the balance payment remains unpaid within 3 weeks prior to the start date we reserve the right to cancel your booking with no refund of deposit. We accept the following payment methods:

Cheques or bank drafts payable to: 'YUNDA Yachting'.

Bank transfers to: YUNDA Yachting, Commonwealth Bank BSB: 062-016 Account: 10710916

Credit cards accepted: Visa, Mastercard and American Express (complete card authorisation form)

Cash (for any outstanding balances) on the day of the charter.

4. Cancellation - If you have to cancel a confirmed booking for any reason this must be in writing and signed by the person who signed the booking form. The cancellation will be effective from the date it is received by YUNDA Yachting. You are liable for the full charter fee unless cancelled more than 3 weeks before the charter, in which case only the deposit is forfeit. Holiday insurance, including cancellation cover, is **strongly recommended**.

In the event that YUNDA Yachting has to cancel the charter for whatever reason, YUNDA Yachtings' liability will be limited to payments already received from you for that charter, and there shall be no liability on the part of either party to pay compensation to the other.

5. The Yacht - YUNDA Yachting reserves the right to change the yacht at any time, prior to or during the charter, in the event of technical problems, damage, or any other reason.

6. Clients Obligations -

The Client hereby affirms:

The details on the booking form are complete, accurate, and not misleading. As required, to give the skipper every assistance in the handling of the yacht and shall comply promptly with his instructions.

Not to pay any expense on behalf of YUNDA Yachting without getting prior consent.

Not to bring any animals, plants or restricted items, or any illegal goods such as drugs or firearms on board the yacht

To return the yacht at the end of the charter period at the time and place specified on the booking form, free from debt, clear of all personal effects, cleaned, and in the condition as on delivery, with her inventory complete.

To make no claim against YUNDA Yachting for liability under this contract including but not limited to death and injury, loss of earnings or any other direct or consequential costs, except in circumstances where the company is proved to be negligent

The yacht is fully insured against accidents and third party liability, but YUNDA Yachting does not accept responsibility for personal accidents, damage or loss due to your negligence. Unnecessary damage and losses attributed to carelessness of a client will be paid for by the client at replacement price accounting for fair wear and tear.

You are **strongly recommended** to arrange your own insurance cover for cancellation, injury and personal liability.

7. YUNDA Yachtings' Obligations -

YUNDA Yachting shall provide the yacht in good and seaworthy condition complying with the provisions of the Marine Safety Victoria and NSW Maritime Commercial Vessels Code - Category 2C and 1F.

YUNDA Yachting shall endeavour to provide the charter as booked, however the skipper may change the itinerary, postpone or cancel, if in his opinion, bad weather or any other reason, will risk the safety of the yacht or any person on board, or vitiate the insurance, or risk late re-delivery at the end of the charter period. The safety of the yacht and crew shall be a priority

THIS FORM TO BE COMPLETED PRIOR TO CHARTER, OR AT HANDOVER OF THE YACHT

In accordance with the Terms and Conditions of Contract attached to this Booking Form, each crew member acknowledges that by signing below, he or she agrees to make no claim against YUNDA Yachting for liability under this contract including but not limited to death and injury, loss of earnings or any other direct or consequential costs except in circumstances where the company is proved to be negligent. Holiday Insurance covering these risks and others can be taken out with various providers.

All crew members also warrant that they are fit to take part in the charter and to the best of their knowledge do not suffer from any condition likely to be aggravated by the charter. Such conditions may include diabetes, epilepsy, asthma, giddy spells, angina and other heart conditions.

All crew members also warrant that they have been given, and understand, the following safety briefing:

Safety Information

This information will also be included in a safety briefing before departure. It is a condition of booking that you ensure that you have received and understood the safety briefing, including the following:

Footwear: Decks can be slippery when wet. Footwear must have soft soles with good grip. Under no circumstances are work boots permitted on board.

Lifejackets: May be worn at any time on-board, except when inside the cabin. Lifejackets and lines to be used: in darkness; fog; rough weather; personal choice.

Winches: use winches respectfully and beware of trapped fingers

The Boom: beware of serious head injury from the boom (the boom is the horizontal metal bar above the cabin). Keep your head below the level of the boom at all times. The boom can swing extremely quickly and without warning.

Locker doors: Beware of trapping/damaging fingers when using cockpit lockers.

Hot water: hot water in the taps can sometimes be very hot and can scald.

Cooker: the cooker has a mechanism allowing it to swing, so beware hot food/water does not spill onto you.

Man overboard: Be aware of procedures for a man overboard situation.

Safety Equipment: Be aware of location and how to use appropriately.

Liferaft / lifebuoys: Be aware of location and method of launching

VHF radio/EPIRB: DO NOT operate unless instructed by Skipper or an emergency.

Engine operation: DO NOT operate the engine unless instructed by Skipper.
